OF THOSE ADOPTED, SOME REQUIRED SPECIAL MEDICAL CARE AND REHABILITATION DURING THEIR TIME AT TENTH LIFE. EXAMPLES INCLUDE: BOTTLE FED NEONATES, INJURED PAWS, LIMBS, AND TAILS, DEFORMITIES AND NEUROLOGICAL DAMAGE NEEDING SPECIALIZED CARE, HEART MURMURS REQUIRING MEDICATION, AND VISION IMPAIRMENTS. THE STORY OF EACH CAT IS UNIQUE BUT EACH ONE ENDED WITH A CAT BEING PLACED IN A HOME WHERE THEY WILL BE GIVEN THE LIVES THEY DESERVE.
